Philanthropy for people and planet

Philanthropy is, for the most part, in a privileged position.

members across all of our priorities and the increasing momentum behind working together for common goals illustrate the relevance of our strategy.

This review covers 2023, the first year of our Strategic Framework, which runs to 2027. As such, we have structured it according to the Framework’s five Impact Goals:

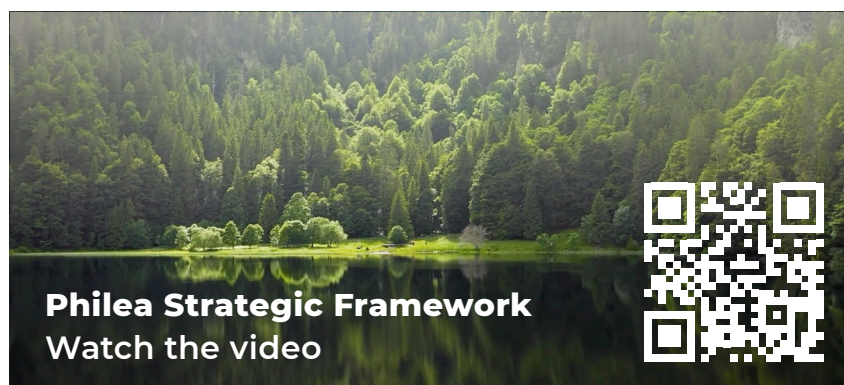
1. Building the community

2023 – The first full year of Philea’s 5-year Strategic Framework

This was a year of collectively imagining the journey ahead as Philea laid the foundations for its role and impact for the sector.

By the end of 2022, following deep and wide consultation with members, the development of a long-term strategy for the organisation was well underway. During February and March 2023, we spoke with 73 members to gain feedback on the proposed vision, mission and objectives of Philea. During the AGA in May 2023, the membership firmly endorsed the resulting 5-year strategy.

Strategic Framework for 2023-2027

Philea’s vision is for philanthropy to use its full potential to co-shape and support a pluralistic, just and resilient society that centres people and planet.

To achieve this vision, Philea galvanises collective action and amplifies the voice of European philanthropy. Together we:

- Co-create knowledge and learn from effective practices
- Collaborate around current and emerging issues
- Promote enabling environments for doing good

5 IMPACT PRIORITIES TO REALISE OUR VISION:

1 Building the community

We want members to have a sense of belonging to a mutually reinforcing community, and to come together around key agendas for people and planet.

2 Empowering the community

We want the community to generate collective action and impact, and we want Philea to be recognised as a reference centre for collective thought leadership.

3 Advocating for and connecting the sector

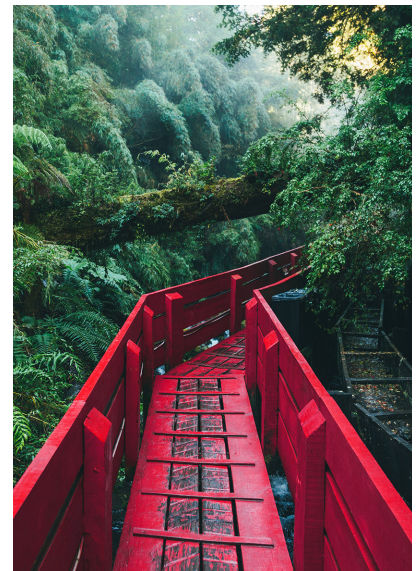
We want philanthropy to thrive in an enabling environment and be well connected to key partners.

How our work in 2023 moved us forward

With a clear, mandated direction ahead, we ensured that our 2023 work plan contributed to Philea’s impact priorities and the difference we are trying to make for our members and the wider community.

In the pages ahead, you’ll read about the work we carried out under each of the priorities in 2023. While virtually all we do is connected in one way or another to all of the priorities, each activity area does have a primary home in one of them. We’ve organised this report based on that premise. Each major section encompasses the work done under a particular impact priority, featuring activity highlights from the year.

We hope you enjoy reading about our work in 2023, and how these efforts have moved Philea closer to realising its vision.

BUILDING THE COMMUNITY

We want members to have a sense of belonging to a mutually reinforcing community, and to come together around key agendas for people and planet.

As a membership organisation, Philea is dedicated to ensuring that our members see the value of being part of a community that helps them find answers to their pressing needs and connects them with peers around conversations that matter to them. We want our members to see also that Philea itself is in turn part of a larger community, a complex ecosystem where partnerships and bridge building are essential components of enhancing the impact of Philea and the philanthropy sector.

In 2023, through our peer-learning and thematic communities and networks; PEX Forum; annual Philea Forum; and other peer-learning initiatives, we worked to ensure that our members felt part of both the Philea community and the wider European sector.

2023 Highlights

Communities of Practice (CoPs)

Focusing on specific areas of practice within the philanthropy sector and comprising philanthropy professionals who meet regularly throughout the year to exchange knowledge and expertise, these peer-learning networks are some of Philea's most valued membership services. In 2023, there were 10 CoP events welcoming 461 participants.

We launched 4 new CoPs in 2023 that brought practitioners together to learn from one another on the following issues:

The **Evidence and Learning** group focused on new paradigms and practices, and inspiring new thinking. Members delved into measuring impact with a trust-based philanthropy model, strategic frameworks in systems change, and tackling power imbalance.

The **Data Science** CoP brought together data scientists and data enthusiasts working within the philanthropic sector to explore how data can inform funding. The group analysed the results of a Philea members survey with the aim of producing a publication in 2024.

The **European Network of Enterprise Foundations (ENEF)** addressed the unique challenges of enterprise foundations and how they can collaborate in the political and philanthropic space.

The **Funding Strategy Network** gathered for a discussion around Transformative Philanthropy in Transitions.

PEXcommunity – Connecting European philanthropic infrastructure

We continued to cultivate the PEXcommunity, a group of over 350 philanthropy professionals from 70 infrastructure organisations working in thematic, regional, national, European and global networks. Over the spring and summer, an extensive evaluation was conducted on the role and value of PEX. More than 60 people, representing over 50 philanthropy infrastructure organisations, participated in workshops, interviews, focus groups and a survey. The evaluation results provided the basis for the strategy development of PEX in the next phase.

Thematic networks and funders collaboratives

In 2023, we also continued to develop our 14 thematic networks and funders collaboratives which are the anchor points of thematic conversations within Philea. These networks delivered a rich and varied programme of activities including 15 events with 533 participants, a resource repository, working groups and webinars to bring members together around topics of shared interest and to nurture collaboration.

Some of these thematic networks worked to mainstream and build the case for key issues, such as meaningful participation of **children and youth**; advancing **gender equality** across foundations' programmes and operations; how **funding quality journalism** can positively impact a foundation's overall mission; and the urgency to safeguard our democracies. For

example, the networks on **Disability** and **Children & Youth** met jointly in Vienna, in the frame of the Zero Project Conference, to explore the participation and inclusion of young people with disabilities. The **Democracy Network** created a list of projects around the European elections where additional funding could help safeguard our electoral health.

Other networks offered valued spaces for experts to explore key trends and developments and discuss philanthropy practices with CSOs, academics and foundations on a range of topics (research and innovation, arts and culture, etc.). Some of these discussions are specific to a geographical area, such as in central and eastern Europe (**KoneKtor**) or Africa (**Funders Forum on International Cooperation Partnerships**).

BRIDGE programme

The philanthropic sector is experiencing changes due to the disruptive global environment, and we want to make sure that we are grasping the full potential of member-driven collaborations to achieve greater impact. That's why in 2023 we launched the BRIDGE programme. It brought the chairs and co-chairs of the thematic networks together for the first time with a view to helping them be better connected and more able to build on each other's work, and to help them tackle thematic issues through an intersectional lens.

Learning and training activities

500 staff from across our membership took part in our learning and training activities, with an average score of 4.3/5 for relevance and 4.1 for learning from participants.

Philanthropic Leadership Platform (PLP) China-Europe

2023 also marked the beginning of a new 3-year grant cycle (2023-2025) for the Philanthropic Leadership Platform (PLP) China-Europe programme in a new partnership with the China Foundation Forum (CFF). The highlight of the project in 2023 was the implementation of a new edition of the PLP event in Brussels in September, bringing together 18 participants from 17 philanthropic organisations. The Brussels programme took place over the span of 7 days, between 17-23 September, and was rated as 9.5/10 by delegates. Key outcomes included enhanced awareness among participants over how philanthropy has been shaped in each geography; insights into similarities and differences between the regions; and cutting-edge knowledge by practitioners and thought leaders who provided new insights.

Philea Forum 2023

Under the title “A New Compass for Europe: Forged in Crisis, Forward in Hope”, Hosted by the National Foundation for Civil Society Development – Croatia, the 2023 Philea Forum was held from 23-25 May in Šibenik, Croatia. Our flagship event brought together almost 700 philanthropy and civil society professionals who were offered a creative haven to plot a new course – given the treacherous seas we are navigating – towards the kind of Europe we want and need.

Several key issues arose throughout the 3 days of sessions and site visits:

The importance of supporting democracy, in particular within the contexts of the climate crisis and the war in Ukraine.

The evolving relationship between funders and their partners as well as the importance of unrestricted funding.

Human rights and equality as essential elements of solutions to each and every one of the crises Europe and the world are facing.

Youth participation and the importance of intergenerational solidarity and solution building as crucial in addressing these issues.

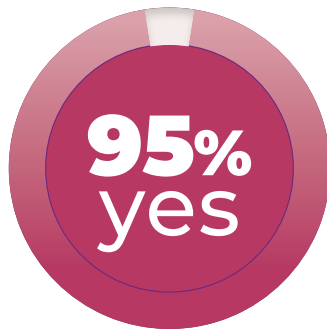

EMPOWERING THE COMMUNITY

We want the community to generate collective action and impact, and we want Philea to be recognised as a reference centre for collective thought leadership.

In 2023, we continued to strengthen collaborations and generate knowledge as key elements of driving collective impact and action. We also produced and published

a range of content on the sector, which helped us in our aim of being a resource for knowledge on philanthropy and a thought leader in the sector.

2023 Highlights

Strengthening transformations and collaborations

Our thematic networks such as the European Foundations for Sustainable Agriculture and Food and the European Philanthropy Coalition for Climate (Climate Coalition) focused on strengthening transformations and collaborations. For example, our Climate Coalition supported the development of #PhilanthropyForClimate – a global movement of over 600 foundations based in Europe. Key milestones in 2023 included the launch of the Polish Climate Commitment hosted by the Polish Donors Forum, and reporting across all European commitments which demonstrated clear progress by signatories to integrate climate into their programmes, operations and funding.

Empowering philanthropy through data on the sector

Designed by our Data Task Force, which acts as a soundboard and meets twice a year to discuss and reflect on the many activities relating to data on philanthropy, our annual survey of Philea's Philanthropy Infrastructure Organisation (PIO) members resulted in three outcomes:

1. A benchmark of PIO members.
2. An analysis of trends in European philanthropy from a national-level perspective.
3. Key figures on institutional philanthropy in Europe.

These are crucial because they provide a comprehensive benchmark for PIO members, offer insights into evolving trends in philanthropy from a European country perspective, and present essential data on the size and scale of the sector. The data showed that Europe is home to 186,079 public-benefit foundations across 26 countries, with a collective worth of €647.5 billion and annual expenditures of €54 billion..

Information request service for members

In 2023, we responded to 84 requests for information, focusing on the following topics:

The “Data on philanthropy – by us, for us” webinar series

This initiative of Philea in collaboration with the European Research Network on Philanthropy (ERNOP) focuses on leveraging data on philanthropy in Europe, emphasising how the sector uses this information. In 2023, events focused on:

- “Common Taxonomies in European Philanthropy”, which explored the diverse uses and benefits of taxonomies and highlighted how taxonomies contribute to better research, informed decision-making, enhanced collaboration and improved coordination, accountability, and transparency within the philanthropic sector.
- “Understanding National Philanthropy Landscapes: France”, where in addition to learning about the size, scale and focus areas of French foundations and emerging internal practices, participants from all over Europe learned about the quantitative and qualitative methods used for the study.

Research collaboration

We continued to support research collaboration and represent Philea at joint academic conferences including the 11th International Research Conference of the European Research Network on Philanthropy, which took place in Zagreb from 29-30 June, and focused on the overarching theme of philanthropy and crises.

We began a closer collaboration with the Center for Effective Philanthropy which entails publishing results from our studies and informing their predominantly North American audience about the developments in European philanthropy in the form of a reciprocal blog series which started in August.

Organisational Development (OD) Community of Practice

Our Organisational Development Community of Practice held its first in-person event in March which centred on the issue of power and how it manifests in grantmaker-grantee relations.

Communications Professionals in Philanthropy Community of Practice

The Communications Professionals in Philanthropy Community of Practice came together in April in Philanthropy House in Brussels to explore how foundations can be politically engaged yet remain neutral.



CEO Exchange

During our CEO Exchange we convened a space to discuss issues of hope and concern, including around leading change, embedding DEI in philanthropic practices, using the voice of foundations, and how to maintain the balance between optimism and realism in difficult times. CEOs engaged in the group met twice online and once in Brussels at Philanthropy House for a full-day exchange, sharing their personal perspectives and learning from each others' respective views.

Operations Professionals Network

Our Operations Professionals Network held its summer meeting in Berlin under the title “Beyond Diversity, Towards Equity and Inclusion” in June. The event took participants beyond diversity to take an equity-based approach, acknowledging that situations of injustice have structural elements and deep roots, and different people and geographies remain in disadvantaged positions because of an uneven playing field.

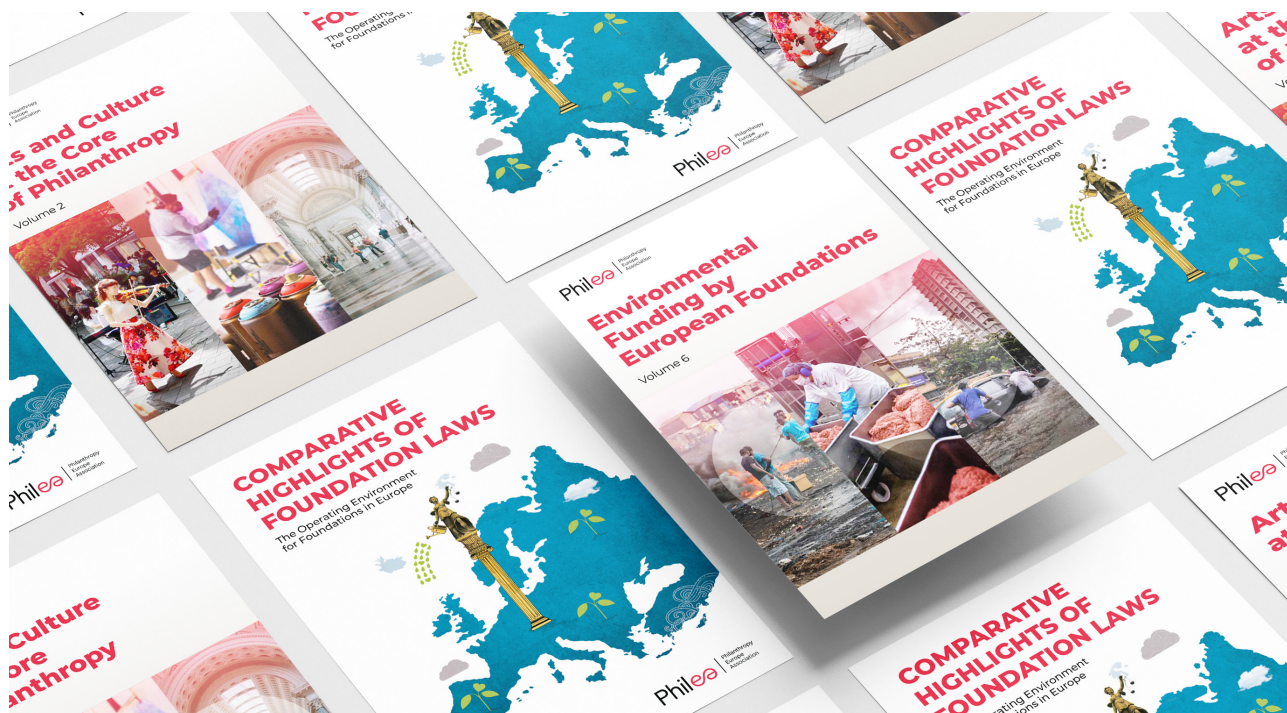
Futures Philanthropy

In April, we launched the Futures Philanthropy initiative at a dedicated “What if? Reimagining philanthropy” event, introducing the new wide-ranging programme that is dedicated to building futures literacy to support long-term thinking and transformative change in the philanthropic community. The initiative offers research insights, as well as opportunities for collaboration and learning. Together with the BMW Foundation, we organised the first Futures Philanthropy gathering of leaders, bringing together CEOs, board members, strategy directors and foresight specialists to foster exchange and collaboration on future philanthropic practices.

News, opinion and online reach

In 2023 we published 61 opinion pieces by 75 authors on the Philea website. The following topics were the most popular:

1. Systems change
2. Infrastructure organisations
3. Impact measurement
4. Arts and culture
5. Intersectional approaches

We disseminated 11 monthly editions of our Philanthropy in Action newsletter for the membership which had a 45% open rate and 12.5% click through rate.

We generated 159 pieces of coverage in mainstream & trade media and newsletter outlets – an increase of 30% from 2022. These ranged from articles on or around our flagship events, opinion pieces and interviews, and included coverage in *Alliance* magazine, *VITA*, *The Philanthropist*, *La Vanguardia*, and *Corriere della Sera*, as well as through *Candid*, *Politico* and *Ritzau*.

Our website views increased by 25.6% from 2022 to 2023, and our social media channels saw an increase in followers of 14.5%.

“Philanthropy Back to the Drawing Board: Shaping a Future Agenda”, by Rien van Gendt

On the European Day of Foundations and Donors on 1 October, and in the presence of European Parliament Vice President Nicola Beer, we released Rien van Gendt’s latest book “Philanthropy Back to the Drawing Board”. The book urges philanthropy to critically and reflectively assess how it can best live up to the promise it makes – and the responsibility it has – of investing private resources for the public good.

THEMATIC MAPPINGS AND REPORTS



The 6th edition of this research into **Environmental funding by European foundations** is the most comprehensive report to date on environmental philanthropy in Europe. The report is based on 2021 grants data from 126 of the largest environmental foundations in Europe. The mapping analyses the 8,518 environmental grants made in 2021 by these foundations, worth a combined €1.6 billion.



This 2nd volume of Philea's research into **European philanthropic funding in the field of arts and culture** reveals a philanthropic sector that is strongly committed to resourcing artistic and cultural organisations to strengthen their resilience; has a cross-cutting and intersectional tendency in its work; and is clearly open to collaborative and participatory approaches.

This edition of the mapping surveyed 64 foundations from 17 different countries, and includes contributions from several experts in the field.



This publication on responsible research assessment aims to explore diverse approaches taken by foundations to enhance the fairness, transparency and effectiveness of **evaluating research proposals for funding**.

It provides an overview of general principles of responsible research assessment, key framing documents and recommendations for implementing these principles; and offers examples of the real-world application of these methods by various foundations and organisations.



The goal of this report is to take a deep and qualitative look into the **listening practices of European foundations**. Talking about listening can sound subjective, but this report shows how this process can be viewed objectively and how these learnings can be used to start improving listening practices within foundations. An executive summary, as well as further reading and resources, are included.

CASE STUDIES

As part of our work on Futures Philanthropy, which is dedicated to building futures literacy to support long-term thinking and transformative change in the philanthropic community, we conducted interviews for a new series of case studies, beginning with "A New Social Contract: Gulbenkian Foundation Advancing Intergenerational Fairness". The series will continue in 2024 with a collection of the case studies included in a new publication.



ADVOCATING FOR AND CONNECTING THE SECTOR

We want philanthropy to thrive in an enabling environment and be well connected to key partners.

In 2023, Philea continued to champion the interests of its members vis-à-vis the EU and multilateral organisations, and to work towards an enabling operating environment for European philanthropy. We carry out this work by monitoring and analysing policy and regulatory trends at national, European, and international level, and engaging around this agenda with policymakers and other stakeholders. We aim to position philanthropy as a key actor on societal issues and facilitate strategic engagement and collaboration opportunities, including public-private partnerships.

2023 Highlights

EU policy affecting philanthropy

Throughout the year, we worked towards implementation of the EU Social Economy Action Plan, including actively contributing to the Social Economy days – held in Gothenburg in June and in San Sebastian in November – on barriers to cross-border philanthropy. The Social Economy Action Plan is crucial to the philanthropy sector because it sets out ways to overcome barriers to cross-border philanthropy/foundation action, as well as ways to stimulate an overall enabling environment for the sector and new collaboration opportunities with EU policymakers.

In September we welcomed the European Commission's proposal to facilitate cross-border activities of non-profit associations in the EU through the creation of a new legal form, the "European Cross-Border Association" (ECBA), in Member States' national legal systems. This is a crucial step towards creating a level playing field for the public-benefit sector and for strengthening civil society space in Europe. This should pave the way for similar initiatives for other entities – such as foundations.

Throughout the year we engaged with non-profit partners and key decision-makers to improve current policies on EU Anti-Money Laundering and Combating the Financing of Terrorism (AML/CFT), which have had an unintended – yet nevertheless negative – impact on our sector.

We successfully expressed concerns and advocated for the undertaking of a fundamental rights impact assessment of the proposed "foreign covert interference directive" before its presentation in December 2023, through high-level meetings with Commissioner Jourova and Commissioner Reynders.

We continued to engage around the Council Recommendations on Civic Space.

We jointly submitted a consultation to the European Commission's Annual Rule of Law report with Civil Society Europe. In the consultation, we called on the Commission to include civic space and civil society space issues in the rule of law review.

In April, we submitted comments on the European Commission's proposal for a Defence of Democracy Package, highlighting how threats to democracy also encompass much broader issues, including the functioning of checks and balances of political institutions.

Updated European Philanthropy Manifesto

In 2023 we launched the updated European Philanthropy Manifesto, which calls for a Single Market for Philanthropy, and acts as a critical roadmap for our policy and advocacy work. It includes messages for the philanthropy sector's advocacy asks in the run up to the next European elections in 2024.



EUROPEAN PHILANTHROPY MANIFESTO



Today's societal challenges require concerted efforts by many actors, be they public, private or philanthropic. More and more people in Europe are keen to engage in philanthropy, but challenges and barriers – especially when acting across borders – persist.

This European Philanthropy Manifesto is a call to policymakers in Europe to work towards a **Single Market for Philanthropy** by taking these 4 steps:

Building the evidence base

Across the year, we continued to develop our evidence base for informing both European- and national-level activities through regular engagement with Philea's Legal Affairs Committee (10 meetings in 2023) and collecting case studies. We continued to build the capacity of members and the wider sector through:

- 10 capacity-building and information webinars
- 13 analysis pieces
- Updating the joint handbook "How to Use EU Law to Defend Civil Society Space", in collaboration with the European Center for Not-for-Profit Law (ECNL)

Keeping the sector informed

We consider philanthropy to be part of civil society and part of the social economy family, as well as a sector facing its own distinct challenges when it comes to the enabling space. We cannot achieve progress in these fields on our own – that's why we co-organised or contributed to 12 partner and infrastructure initiatives to keep the sector informed of developments in the enabling environment, such as the Social Economy Action Plan as mentioned above.

We want philanthropy to thrive in an enabling environment and be well connected to key partners.

EuroPhilantopics

In November, we convened our annual EuroPhilantopics event in Brussels with more than 100 policymakers and representatives from the philanthropy and wider civil society and social economy sectors to bridge national, EU and international perspectives to develop a more integrated advocacy process.



Recurring themes during the event included philanthropy playing a role in strengthening fundamental rights, rule of law and democratic approaches; the need for more dialogue between public and private funders; removing existing barriers, especially with regard to cross-border philanthropy; unrestricted versus restricted funding; and foundations leaving their comfort zone of neutrality and being honest about capacity and impact.

2023 Highlights

It goes without saying that our members are the beating heart of Philea. They shape, drive and support the organisation at every level and throughout Philea's entire range of activities. To achieve our vision and impact priorities, it is crucial that we grow our membership strategically and work to better support members in their engagement with Philea.

New members in 2023

We welcomed 26 new Full Members in 2023. This brought our total membership to 304, with organisations hailing from 38 different countries. Our membership includes 220 Full Members Foundations and Philanthropic Organisations; 27 Full Members Philanthropy Infrastructure Organisations; and 57 Associate Members. Broadening our membership horizon

We aim to cover as many dimensions as possible within our membership. To do so, we are working towards filling current gaps in our representation of the sector through targeted outreach.

For example, an underrepresented area geographically is eastern Europe, with community foundations making up a key part of this landscape, as well as other forms and vehicles of philanthropy that are different to the traditional composition of the Philea membership. In 2023 we started exploring this landscape through an online session for established and new philanthropy infrastructure in CEE.

Improving engagement opportunities

In 2023 we worked towards better supporting our members in their engagement with Philea by facilitating connections among the membership and giving better access to useful resources through more tailored communication; by designing specific value propositions for different member constituencies to improve understanding of where they can engage; and by seeking data and feedback to continually improve our activities and processes.

Listening Tour

We conducted a month-long Listening Tour in the spring, consisting of one-to-one conversations with representatives from more than 73 members to introduce our proposal for Philea's 5-year Strategic Framework 2023-2027 and to answer their questions and concerns. The input helped shape the final strategic framework, which was endorsed by the membership during the AGA in May.

Membership survey

We undertook a membership survey to understand the experiences and preferences of our diverse membership, and to get members' valuable feedback on a range of questions. Highlights from the survey include:

- A high level of satisfaction, with approximately 88% indicating that they were either satisfied (56%) or very satisfied (32%) with our performance
- An appreciation of the sense of community and inclusivity we offer, and our ability to embrace diversity, foster connections and facilitate peer learning
- A great appreciation for networking opportunities, learning from peers and sharing experiences with fellow members.

STRENGTHENING OUR ORGANISATIONAL CAPACITY

We want Philea to be a caring, learning and resilient organisation, and we want our resources and ambitions to be aligned.

To move toward our vision as an organisation, Philea needs a strong supporting platform that enables its staff to bring their best in the delivery of activities for the membership. It must also be efficient with its resources. In 2023, we focused our efforts on improving knowledge management and developing our organisational culture; as well as streamlining and refining our funding and budgeting strategies and processes.

2023 Highlights

Governance

Philea is fully governed by its membership. Representatives on our governing bodies are all from – and are elected by – our members. These bodies are intensively involved in all aspects of the running of Philea. In 2023, the Board of Directors,

the Nominations and Governance Committee and the Advisory Committee met to provide strategic guidance, support and scrutiny on issues relating to Philea’s financial sustainability, membership composition, partnerships and priority areas of work.

In 2023:

- The Board of Directors focused on the new strategy, financial sustainability, alignment of resources and ambitions with the work plan, and collaboration with others in the ecosystem.
- The Nominations and Governance Committee were concerned with assessing membership applications, discussing membership criteria and developing the membership strategy.
- A first election saw individuals take up seats on the Advisory Committee, which supports the Board of Directors and the Nominations and Governance Committee in aligning with the needs of the communities and ecosystems that we serve. During the May AGA, 15 members were voted onto the Advisory Committee, and their onboarding took place during the latter half of the year. The Advisory Committee were inducted into their new roles and supported on the work plan for 2024.

Funding sources

In 2023 our funding came from the following sources:

- 27% from membership fees,
- 40% from project related funding
- 18.5% from core donations
- 12% from events
- 2.5% from other sources

Knowledge management

We finalised a comprehensive Knowledge Management (KM) strategy, setting the foundation for ongoing and future Knowledge Management activities. The launch of the Yammer (Viva Engage) KM community and the establishment of the KM Circle highlighted our commitment to fostering a knowledge-sharing culture, allowing us to share intelligence, important updates and practical tips across the organisation and with our members.

Employee engagement platform

We implemented Workleap, an innovative employee engagement platform offering a comprehensive suite of tools, including goal-setting capabilities, structured templates for organising one-on-one meetings, leadership tools, and more. The system allowed for the introduction of bi-weekly pulse surveys to monitor staff well-being and mood, allowing for anonymous feedback. The system helps us gauge how we're doing as a team around a set of key engagement metrics, and allows staff the possibility to anonymously raise issues (or celebrate success).

Remuneration review

We conducted remuneration benchmarking to enhance internal equity and establish a sustainable system for the long term.

Organisational culture

We launched our cultural manifesto which outlines the behaviours and attitudes we expect of our colleagues and ourselves.

Team goals

We enhanced professional development by introducing a structured approach to establishing organisational and team goals as the foundation for annual performance review cycles.
